Hrvatska poštanska banka, p.l.c., Zagreb, Jurišićeva ulica 4 (hereinafter: the Bank) in accordance with Article 474 of the Capital Market Act and pursuant to the Notice on the Share Buyback Program for HPB own shares that began on November 8, 2023, with a duration of 2 (two) years, hereby informs the investment community that it carried out the following purchases of HPB own shares on the Zagreb Stock Exchange (ZSE) regulated market, as per the Share Buyback Program:

- 10 shares designated HPB have been purchased on November 3, 2025, at a weighted average price of EUR 304.00 per share, representing 0.000494% of the Bank's shareholder equity
- 5 shares designated HPB have been purchased on November 4, 2025, at a weighted average price of EUR 300.00 per share, representing 0.000247% of the Bank's shareholder equity.

Information about the transactions can be found in the forms attached to this notice.

Following the purchases mentioned before, the Bank is holding a total of 65 own shares, representing 0.003210% of the Bank's shareholder equity.

Shareholder equity of the Bank amounts to EUR 161,970,000.00 and is divided into 2,024,625 common shares at face value of EUR 80.00 each.

In accordance with the Article 5 of Regulation (EU) No. 596/2014 on market abuse ("MAR") and the related Commission Delegated Regulation (EU) 2016/1052 in regards to the regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures ("RTS 2016/1052"), the data on the total quantity/aggregate volume of treasury shares acquired under the Buyback Program and the weighted average acquisition price over the past 7 trading days are available on the Bank's website www.hpb.hr at the following link: ["Transactions from November 3 to 4, 2025 - public announcement"](#).
