- On April 17, 2026, 64 shares, identification code ERNT-R-A, were acquired at average price of EUR 202.00 per share, representing 0.005% of the Company's share capital.

- On April 20, 2026, 79 shares, identification code ERNT-R-A, were acquired at average price of EUR 200.00 per share, representing 0.006% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 18,002 own shares, representing 1.35% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
