

## Prospectus Supplement No. 6 to Base Prospectus, dated April 3, 2025 The Goldman Sachs Group, Inc. Euro Medium-Term Notes, Series F

This Prospectus Supplement No. 6 (the "Prospectus Supplement") to the Base Prospectus, dated April 3, 2025 and approved by the Commission de Surveillance du Secteur Financier (the "CSSF") on April 3, 2025 (the "Base Prospectus"), constitutes a supplement to the Base Prospectus for the purposes of Article 23(1) of Regulation (EU) 2017/1129 (the "Prospectus Regulation"), and should be read in conjunction therewith and with Prospectus Supplement No. 1, dated April 14, 2025 ("Supplement No. 1"), Prospectus Supplement No. 2, dated May 5, 2025 ("Supplement No. 2"), Prospectus Supplement No. 3"), Prospectus Supplement No. 4, dated August 4, 2025 ("Supplement No. 4") and Prospectus Supplement No. 5, dated October 14, 2025 ("Supplement No. 5"). The terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement.

To the extent that there is any inconsistency between (a) any statement in this Prospectus Supplement or any statement incorporated by reference in this Prospectus Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, Supplement No. 1, Supplement No. 2, Supplement No. 3, Supplement No. 4 or Supplement No. 5, the statements in (a) above will prevail. Save as disclosed in this Prospectus Supplement, as at the date hereof there has been no other significant new factor, material mistake or inaccuracy which would affect the assessment of securities to be offered to the public or listed and admitted to trading on an EU regulated market pursuant to the Base Prospectus as previously supplemented by Supplement No. 1, Supplement No. 2, Supplement No. 3, Supplement No. 4 and Supplement No. 5, relating to the information included in the Base Prospectus, since the publication of Supplement No. 5.
